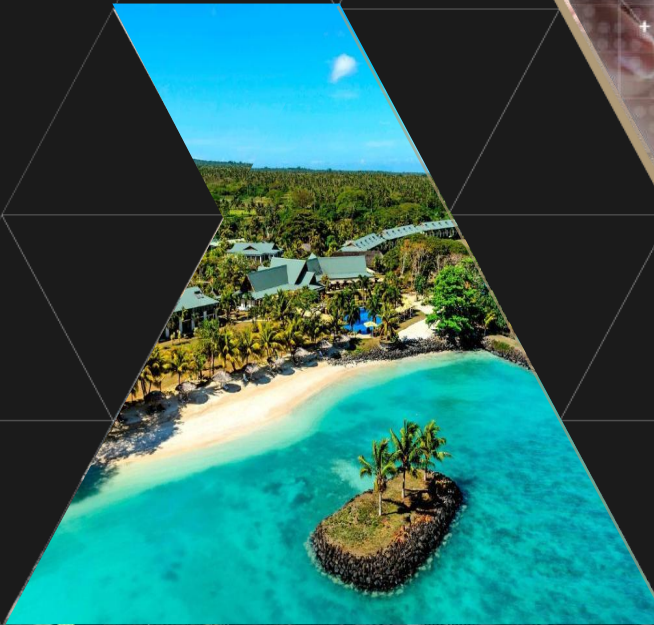

Republic of Kiribati

- **Country Overview:** Kiribati is a Pacific island nation composed of 33 coral atolls, with a total population of approximately 120K. The capital is located in Tarawa.
- **National Policy:** In recent years, the Kiribati government has focused on the openness and development of the blockchain and crypto asset industry.
- **Future Goals:** Kiribati aims to become a global leading blockchain financial special zone, promoting the development of the blockchain economy worldwide.

Enjoy Commonwealth Citizenship Benefits

Holders of a Kiribati passport can travel visa-free to all European countries, including those in the Schengen Area, and enjoy a six-month visa exemption for the UK, allowing them to study, work, start a business, and drive there. Additionally, they can travel visa-free to most Asian countries, including Japan, South Korea, Dubai, Malaysia, Hong Kong, Macau, Singapore, and the Philippines.

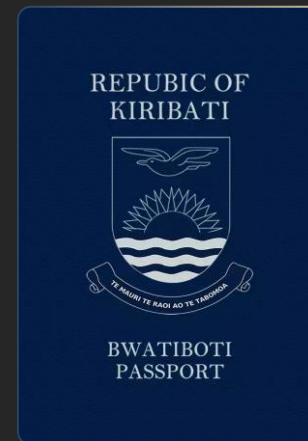
Visa-Free Countries and Regions: 128

1. Stay in the UK for 180 days without a visa.
2. Stay in the Schengen Area for 90 days within every 180 days without a visa.
3. In Asia: Includes Singapore, Malaysia, Thailand, Indonesia, Vietnam, the Philippines, Brunei, and Myanmar.



Global Passport Index Ranking: TOP 33

According to the Guide Passport Index, the Kiribati passport currently ranks 33rd worldwide. The personal power rank is 75, with a global mobility score of 130 points and an overall score of 150 points.

Visa-free access to 128 countries and regions greatly facilitates business and investment activities. It also serves as a safeguard for you and your family in case of emergencies.

Easily register on major cryptocurrency exchanges and investment platforms worldwide, allowing you to bypass local investment restrictions and seize global wealth opportunities.

Offshore Investment and Tax Havens

Kiribati provides a favorable legal and tax environment for direct overseas company ownership, simplifying offshore investments and listings while avoiding complex VIE structures. For individuals seeking global financial freedom and cross-border business opportunities, the Kiribati passport is an invaluable asset.

Kiribati: A Zero-Tax Country

Kiribati is a zero-tax jurisdiction, recognized alongside the British Virgin Islands, Cayman Islands, and Seychelles as a leading offshore tax haven. It does not tax worldwide income and has no capital gains or property taxes, making it an ideal low-tax environment for high-net-worth individuals and multinational corporations.



Overseas Listing

The advantage of Kiribati identity is its relaxed legal environment, which imposes minimal restrictions on capital flow and cross-border operations. Kiribati companies can hold shares directly, simplifying compliance in overseas capital markets.

Kiribati is not part of the CRS (Common Reporting Standard), so holders' financial information is not automatically exchanged with other countries, enabling flexible tax planning and asset management.

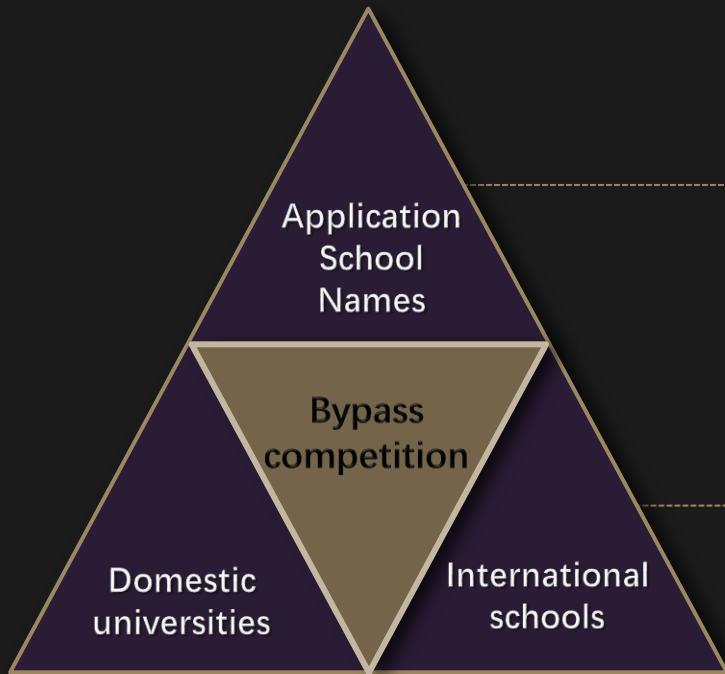


Global asset privacy

A Kiribati passport helps individuals and businesses conceal overseas assets, reducing risks from policy changes, tax claims, and asset freezes, while providing greater security and flexibility for cross-border ownership and inheritance.

Education Planning for Children

Many developing countries, including China and India, have limited educational resources and intense competition. Top international schools often exclude locals. With a Kiribati passport, children can attend international schools, receive standardized exam transcripts, and apply to European and American universities with less competition. For example, the acceptance rate for domestic students at Tsinghua University in China is below 0.001%, while foreign students enjoy a 17% acceptance rate.



Commonwealth Status for Top UK University Applications

As a member of the Commonwealth, Kiribati citizens have an easier pathway to apply to prestigious UK institutions.



Enrollment in Top International Schools

Citizens can apply for admission to the country's top international schools as foreign students.

University Applications as International Students

In the future, citizens can apply to national universities as foreign students, bypassing the competitive local college entrance exams.

Infrastructure Investment

Applicants must invest \$500,000 in the Kiribati National Infrastructure Fund, which focuses on enhancing and developing the country's infrastructure, making significant contributions to its economic and social development.

02

Innovative Project Investment

Investing \$150,000 in the tokens issued by the Kiribati Crypto Bank project allows for citizenship application.

03

Government Donation

Applicants can donate \$180,000 to the Kiribati government, which will be directly allocated to national development projects, demonstrating the applicant's commitment to Kiribati society.

04

Bank Fixed Deposit

A fixed deposit of no less than \$1,250,000 must be made in a designated bank account in Kiribati for a term of 10 years.

05

Real Estate Investment

Investing over \$250,000 in real estate in Kiribati qualifies the applicant for citizenship.

Only basic documents are required

Compared to other small countries (like St. Kitts or St. Lucia), the cost of applying for citizenship in Kiribati is much lower, with simpler document requirements and a significantly faster processing time.

Upgrading to a Diplomatic Passport

Investment Upgrade for Diplomatic Passport

Investing over \$500,000 can qualify you for a diplomatic passport upgrade. By investing more than \$500,000 in this funding round for BeingFi, you may be appointed as an Economic Counselor by the Kiribati government and receive a diplomatic passport.



- **Criminal and Civil Immunity:**

Diplomatic personnel have immunity from criminal and civil jurisdiction in the host country, which cannot prosecute or judge them.

- **Tax Exemption:**

Diplomats are exempt from taxes on income and property in the host country.

- **Personal Security Protection:**

The host country must ensure the safety of diplomats and their families.

- **Communication Immunity:**

Diplomatic documents, mail, and communication devices are protected from inspection or interference by the host country.

- **Inviolability of Residence and Offices:**

Diplomatic residences and offices are inviolable and cannot be entered or inspected by the host country.

- **Diplomatic Vehicle Exemption:**

Diplomatic vehicles typically have exemptions from traffic laws and parking restrictions.

- **Property and Baggage Exemption:**

Diplomats' personal belongings and luggage are protected from inspection, seizure, or requisition by the host country.

Best-Value EU Visa-Free Passport

The Kiribati citizenship program offers the best value for EU visa-free access. Compared to St. Kitts and Nevis or Saint Lucia, Kiribati has faster processing, lower due diligence requirements, and a lower investment threshold. Unlike Vanuatu, Kiribati offers visa-free access to more countries and a passport with higher prestige. Additionally, investments are profitable and can be recouped, making Kiribati the top choice among small-nation immigration options.

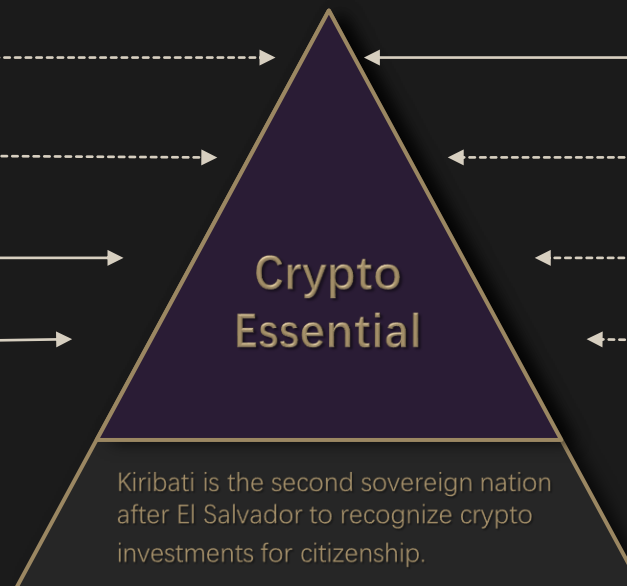

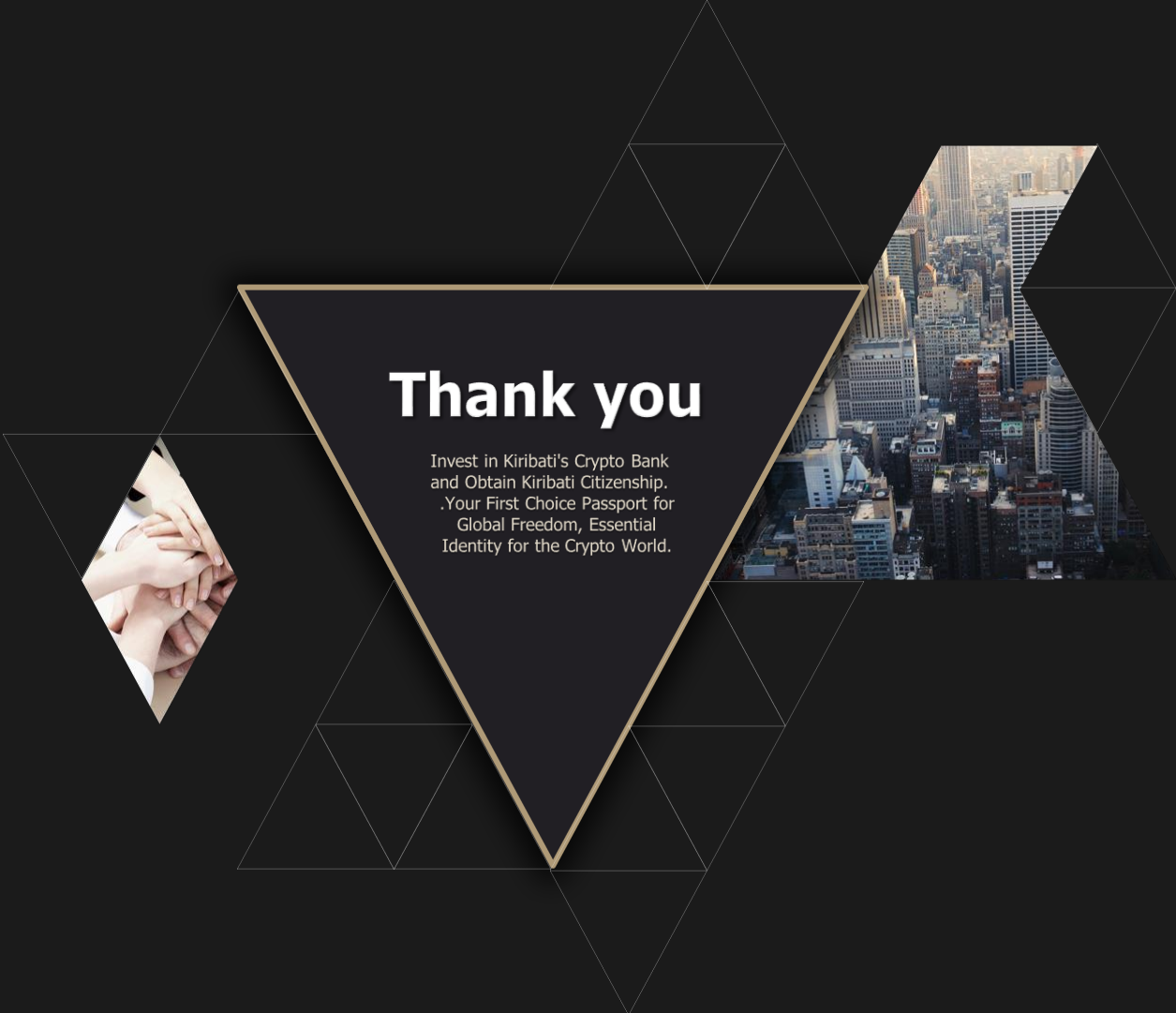
